Alongside this document there are useful training videos embedded within the FA Whole Game System to help you complete the process.

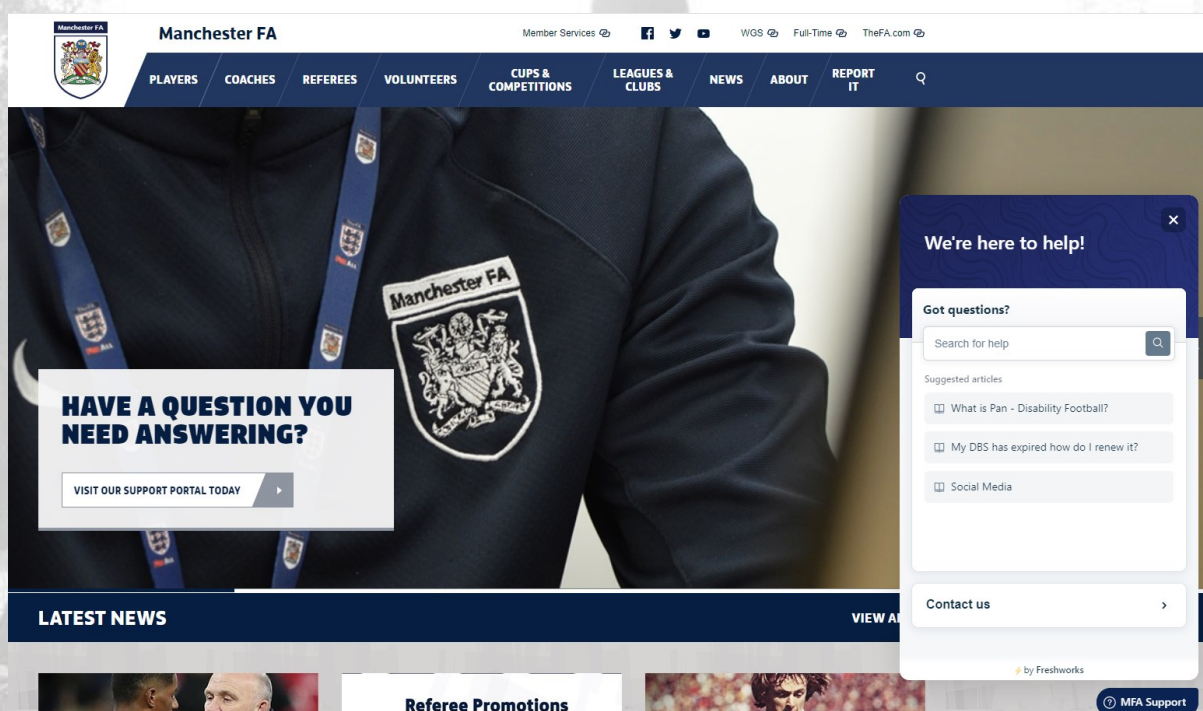
What do I do if I have a question?

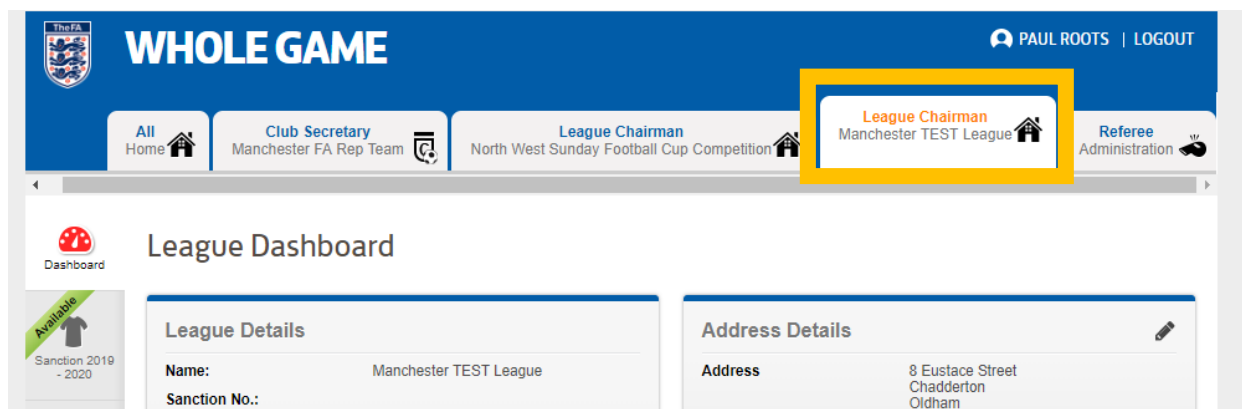


3. My Roles

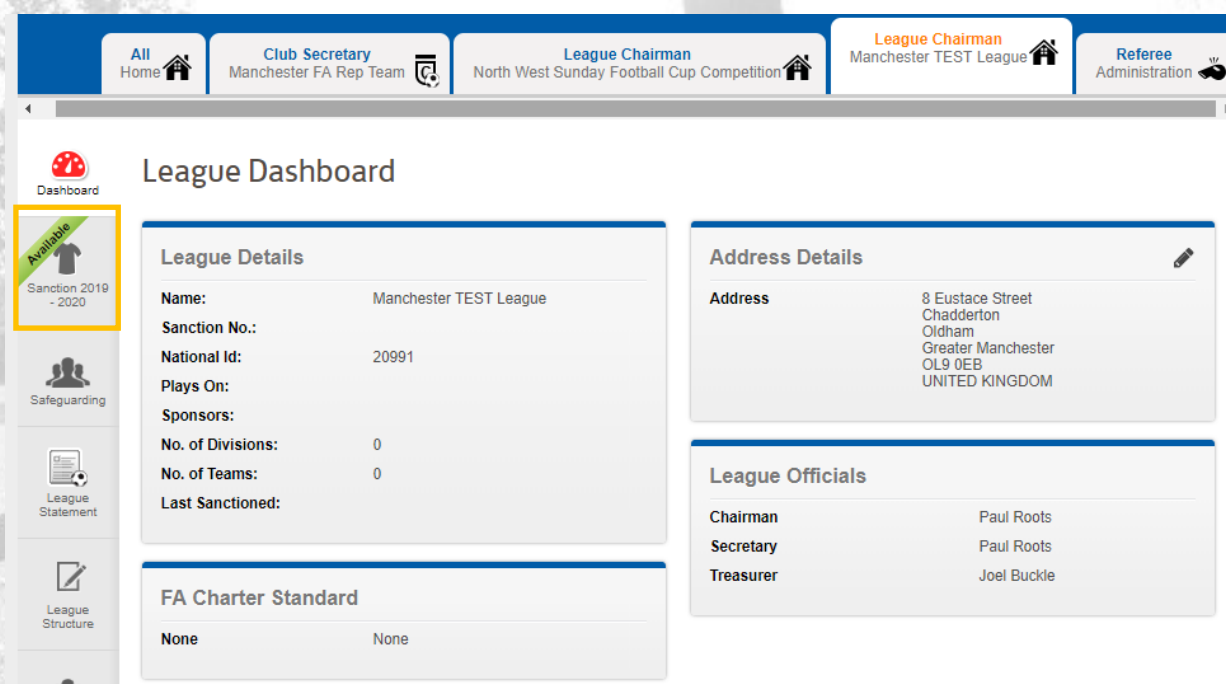
Please click on the senior role that you hold highlighted below, for the majority it will be **Secretary**.

11. Confirmation of Sanction

Congratulations, you have now successfully submitted your league sanction application to Manchester FA where a member of the team will now review the submission.

PLEASE NOTE; Any further changes to your application will now need to be made by a member of the Manchester FA team.

12. Full Time Integration

Once your sanction application has been paid and fully approved by a member of the Manchester FA team, we will request Full Time Integration for your league (where required). All of the teams and divisional data confirmed in the Whole Game System will then be transferred to Full Time.

PLEASE NOTE; Do not try to create a league season in full time as the integration process will override the work you have already completed.
